

## Statement of Cooperation

In making an application for my child, it is my desire to have him/her complete the school year 2025-2026. I also give my child permission to take part in all school activities, and school-sponsored trips away from school premises, and absolve the school from liability for any injury to my child or myself at school or during any school activity.

It is my understanding that J.U.M.P. Ministries Global Church Academy maintains a strong order of discipline and standards and has my permission to enforce discipline. JMGA enforces a drug and alcohol-free work and school environment; therefore, students who use alcoholic beverages, tobacco, drugs, profanity, or who have questionable morals, may be dismissed from enrollment.

I authorized the school staff to take whatever emergency medical measures necessary for the protection of my child while in their care. This includes calling a physician, implementing his instructions, transporting my child to a hospital or clinic without first obtaining my permission or administering life-saving medications such as Albuterol or an epi-pen.

I understand that if I withdraw my child at any time after registration, I am responsible for 20% of tuition for the remainder of the school year. This amount is in addition to my current balance. I also understand that no records will be released until all bills are paid in full. Books and electronics must be returned upon a student's withdrawal from school.

As a self-pay option, I understand that testing, registration, curriculum material, books/ebooks rental fees, and other fees are non-refundable. Tuition is billed in 10 equal payments from August to May and is due on the first of each month. A \$25.00 fee will be charged for each NSF check.

The school reserves the right to dismiss any student not cooperating with the educational process or whose tuition is delinquent for 30 days.

JMGA admits students of any race, color, and national or ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. JMGA does not discriminate on the basis of race, color, or national or ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and school administered programs. ## **Attendance Policy**

JMGCA allows students to be dropped off at designated area and may enter the building as early as 7:45am. Students are to remain seated and may eat their breakfast if brought with them until 7:55am. School begins promptly at 8:00am for all grades, and attendance will be taken at that time.

### **Tardy**

1. Students who enter the building after 8:00am are required to sign in with the Registrar and will receive a pass to enter the class. Any student after 8:10am will be marked tardy. For a tardy to be **excused**, a handwritten note must be provided by the parent or from the doctor's office (if applicable).
2. Three un-excused tardies will equal **one absence**. Six un-excused tardies in a class during a nine-week period will result in a grade reduction of one full letter to reflect a lack of class participation.

### **Absences**

1. An absence can be **excused** by providing a handwritten note from the parent or from a doctor's office (if applicable) on the day the student returns to school.
2. It is entirely the **student's responsibility** to secure missed assignments and complete all makeup work promptly. Failure to do this will be reflected in the student's grade. Students will be given ample time to make up any missed work.

Please take note that if a student's combined excused and un-excused absences and tardies for the school year are excessive and/or over 20 absences, that students records will be reviewed as it could affect the student passing. It will also impact any student receiving scholarship funding.
